## Eliminating indoctrination

To the editor:

Despite the claims in his unhinged letter to the editor last month, Kiel Area School District (KASD) School Board President Dan Meyer cannot read the hearts or minds of anyone.

I counted Dan, the actual number is not 5,000 or 10,000, or 1,000 or even 500, or 100 or even 50. Other than two expensive stunts our taxpayer-funded attorney pulled just days before the last School Board elections—a scandal for another day-the number of pages of public records that I have received is less than 1 percent of what Dan claims. The real number is only 31!

Dan also claims those 31 pages cost the district over \$15,000.

Really?! Is President Meyer merely creat-ing false and misleading impressions, or is he using his elected position to knowingly make blatantly untrue public statements with the intent to deceive everyone he can possibly reach?

Does Dan know from experience that Dr. Ebert has his back, and is willing to violate state law and withhold open records requests that would expose the truth? And Brad in turn knows the School Board never holds him accountable, lest they all lose their positions?

When I witness Brad or Dan or the School Board deliberately deceive the public, or when a whistleblower reaches out to me seeking justice, I file an open records request to get the truthful information out and expose the misconduct. It is true, that results in a lot of open records requests.

But most of the really important requested public records remain concealed by Dr. Ebert, which is a violation of state law and daily dereliction of duty and daily just cause for dismissal.

When KASD was caught red handed violating student's rights for "mispronouning" and the whole country gasped at our extremist ideology, dropping the charges was inevitable. Was the School Board posturing as they delayed three weeks and six bomb threats occurred?

President Meyer says it's all

somehow TCC's fault, even though he knows the current School Board stands idle regarding the year-long cover-up of the 2022 "thorough internal investigation," a requested public record that would shed light on the matter.

Dan also didn't mention that it sure was convenient that the bomb threats distracted attention away from the district's ideo logical extremism, and provided a pretext to label Republicans "haters" without justification.
