WHAT IS ASCA?

The American School Counseling Association (ASCA) is an organization that provides training for school counselors in K-12. Their mission is to create social justice agents for systemic change.

While most parents still see them as friendly "guidance counselors" that is no longer true. In 2014, ASCA shifted their role to become the biggest purveyors of Transgender ideology, gender confusion, and Critical Race Theory.

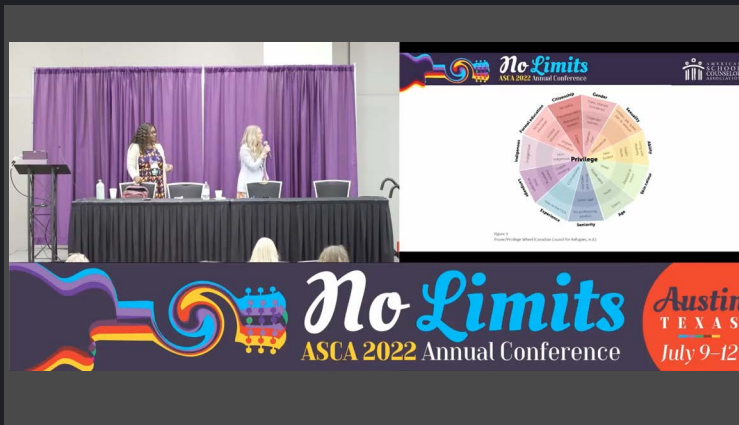

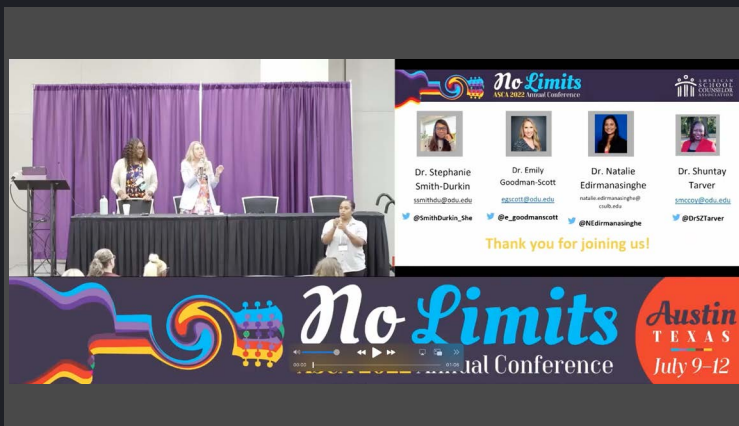
White People

Dr. Emily Goodman-Scott is an Associate Professor in Counselor Education and the School Counseling Coordinator at Old Dominion University, in Virginia. As a previous school counselor and special education teacher, Dr. Goodman-Scott has been in education for nearly 15 years. She was a 2018 recipient of the Top 40 Under 40 award for her region, and served on the Virginia School Counselor Association board for 10 years, including most recently as Chair of the Board (2019-2020). She enjoys speaking at national conferences, invited state association workshops, and school districts trainings.

Dr. Goodman-Scott is the lead editor of the 2019 book *A School Counselor's Guide to Multi-tiered Systems of Support*, and more recently an author of the 2020 book published by the American School Counselor Association, *Making MTSS Work*. 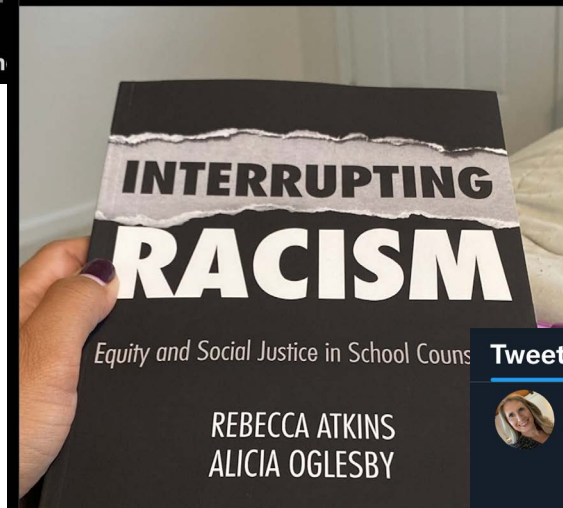

WHAT PARENTS SHOULD KNOW...

ASCA trains school counselors to hide students' sex and gender preferences from parents. They also partner with radical organizations such as GLSEN and bring in GSA clubs in K-12. These organizations advocate for:

- Pronoun and/or name changes to be hidden from parents
- Transition closets in the classroom without parental knowledge
- Sexually explicit books made available to students
- Transgender topics to be introduced in elementary school

PARENTAL RIGHTS 3-DAY NOTICE

I, _____, as parent and/or legal guardian of

_____, a minor child, am hereby providing notice that if you become aware, directly or indirectly, that my child has requested to be known by different pronouns, by a different name or otherwise communicates or exhibits behaviors that communicates a desire to transition gender or sex, you should notify me within three (3) business days of having learned such information. Notification should be attempted by at least two (2) different methods of communications (e.g., phone call, text, email, mail). Without my prior written consent, under no circumstances shall my child be referred to or engage with any on-staff school counselor, contracted school counselor, social worker, or any mental health professional.
