The correct steps as I understand them should be the following:

- Submit your complaint/concerns to Dr. Ebert, via email or in writing (usps or personally dropped off at the district office)
 - No need to use a specific form at this time, however, include the who (against), what (violation you are claiming if you can clearly identify one or do your best), when, where, and why of your complaint (what damages does it do).
 - From this information, the district office will conduct a preliminary investigation to outline the steps and protocols that will be followed on how the complaint will be handled and proceed (as an example, who will be assigned to do a full investigation; Dr Ebert, an internal (KASD) compliance officer or and external one (from another school district or a retired district administration in the state) and if it is an internal violation (local policy) or violation of state statutes (that may include a referral to dpi or local district attorney) etc.)
- You are welcome to cc myself if using email to file your complaint as an accountability and notification process. That doesn't mean I will be responsible for taking the lead on any portions of the investigation or follow through, only that I will assure that it doesn't get "swept under the rug" and that you will get a timely updates on the status (depending upon how long the process takes)
 - You are welcome to cc anyone else you have confidence in to assure proper documentation and follow through, however, I would suggest that you do not include the full board as that may be seen as prejudicial if any parts of the complaint were appealed to the board level.
 - If you choose to have it delivered by usps then it would be best practice to have it sent registered with a signature (I am not suggesting this or that it is necessary to expend \$ on this, however, as best practice, it would avoid claims of not seen or received until...?)
 - If sent via email, I would also suggest you set up a read receipt (for same reasons stated previously for usps)
 - I am not suggesting these steps because I have any doubt in our district administration or office. Instead I make these suggestions as best practice.
- Dr. Ebert is required to follow up on all complaints, to investigate, and make a

determination, or assign a compliance officer to do so.

- That doesn't guarantee your satisfaction or agreement, however, it would be the
 first "hoop" that would need to be gone through before an appeal to a "higher
 authority" (whatever that may be under the circumstances, i.e. board, dpi,
 district attorney, etc.). Unless obviously criminal in nature, any higher authority
 would "kick it back" to this first investigative step if not already done.
- I would also suggest that you kindly (please be respectful, I know you are) request a
 periodic update that would be to your satisfaction (weekly, every 2 weeks, etc.) and
 provide an outline of what next steps you can expect (that can be shared with you, in
 case specific students or others would be involved that are legally shielded) or an
 alternative suggested to you. Again, I suggest this as best practice so that both parties
 can avoid any conflict due to different expectations or misunderstandings.

If you have any additional questions or if there is something I overlooked, please let me know! I do tend to be wordy and include more detail than is necessary on occasion. Unfortunately, if I have not already written a draft (I have not in this case), my thoughts may move faster than my typing and I miss something. If that is the case, I apologize and ask for your understanding.

If there is any more I can do to assist you, please do not hesitate to ask me. I can not state strongly enough how grateful I am for community members such as yourself willing to speak up under very difficult circumstances. It is strong support like yours that inspires individuals like myself to continue to do our best to serve our children and community (C²).


