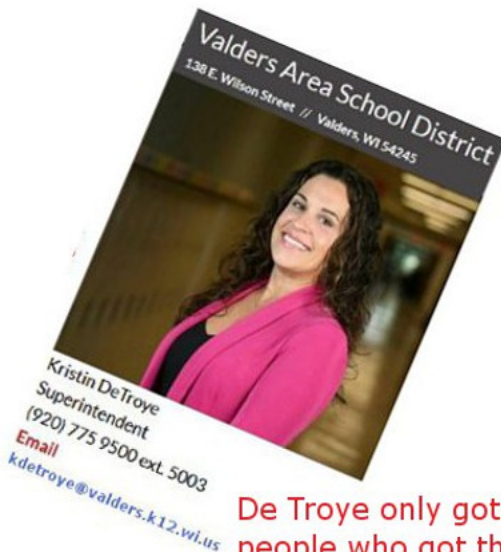
No one elected De Troye to anything anywhere, especially not in KASD.
